

Coinfy Bonus Campaign

Terms and Conditions

These Terms and Conditions (“Terms”) govern the participation in the Coinfy Bonus Campaign (“Campaign”) exclusively for clients referred from Oipax. By participating in the Campaign, users agree to be bound by these Terms.

1. Eligibility

The Campaign is open to new users of Coinfy who register using a valid Oipax referral link or code.

Participants must be at least 18 years of age and legally eligible to use Coinfy services in their jurisdiction.

Only one bonus per user is permitted. Duplicate or fraudulent accounts will be disqualified.

2. Bonus Details

Eligible participants will receive a \$30 trading credit bonus, credited in cryptocurrency.

The bonus itself is non-withdrawable, but any profits generated from trading with the bonus may become eligible for withdrawal.

To withdraw profits made from the bonus, the client must:

- Make a minimum deposit of \$100 equivalent in supported cryptocurrencies into their verified trading account, and
- Trade using their own deposited funds (i.e., open and close trades using the \$100 deposit).

Coinfy reserves the right to:

- Refuse or reverse the bonus in cases of suspected abuse, manipulation, arbitrage, or other violations of the bonus terms.
- Cancel profits associated with the bonus if the trading conditions are not fully met.
- Decline or revoke the bonus and/or related profits in cases where trading activity suggests attempts to exploit the bonus system without genuine market exposure or risk.

Accounts must remain in good standing and verified during the campaign period and until the bonus is applied.

Coinfy reserves the right to modify, suspend, or terminate the Campaign at any time, with or without prior notice.

Any changes will be posted on the Coinfy website and become effective immediately upon publication.
